BASFL has organized Picnic, Saraswati Puja, Holi, Durga Puja, and Diwali Celebration successfully over the years in South Florida.

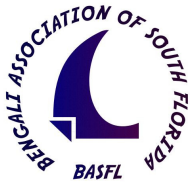
